

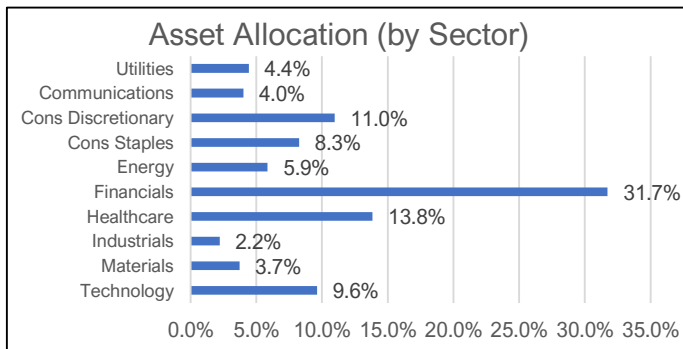
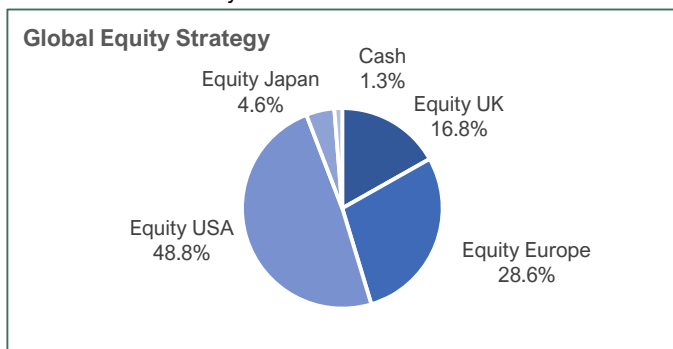
Strategy Description

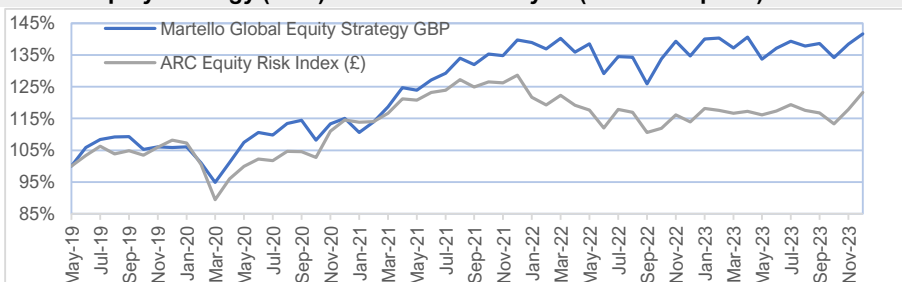
