

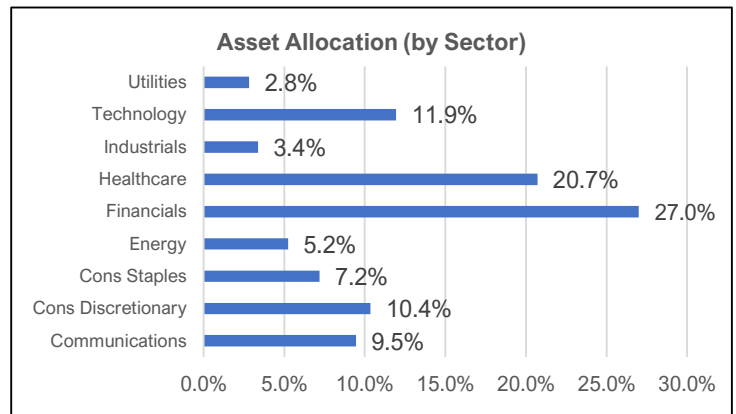
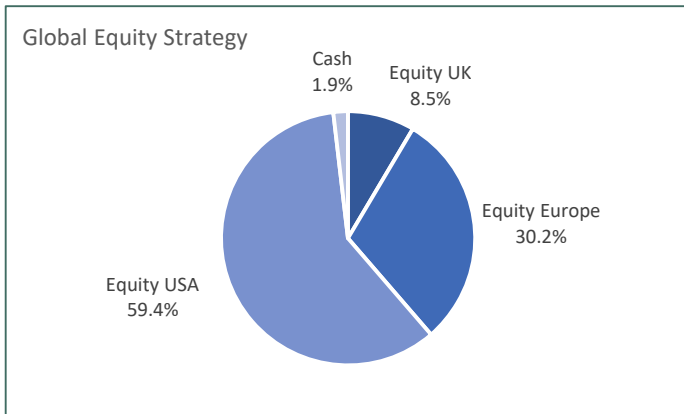
## Strategy Description
