Investment Objective

The Martello Global Equity Fund ("the Fund") aims to achieve long term capital appreciation through investment in listed equities on a global basis.

The fund is primarily intended for investors with a long-term horizon of at least 5 years.

Investment Strategy

The Fund will invest in a diversified portfolio of listed equities. Assets of the Fund are typically limited to, but not confined to, those companies listed on the markets of the UK, Europe and North America.

The investment advisor will apply a rigorous investment selection methodology to select securities for the Fund's investment portfolio. These criteria are designed to ensure that the Fund invests in high quality businesses with proven management competencies and strategy execution.

It is envisaged that the investment portfolio of the Fund will be concentrated, comprising between 20 and 30 stocks. However, the portfolio will be invested with the aim of providing a prudent spread of risk, and there are limits on the concentration of the investments held.

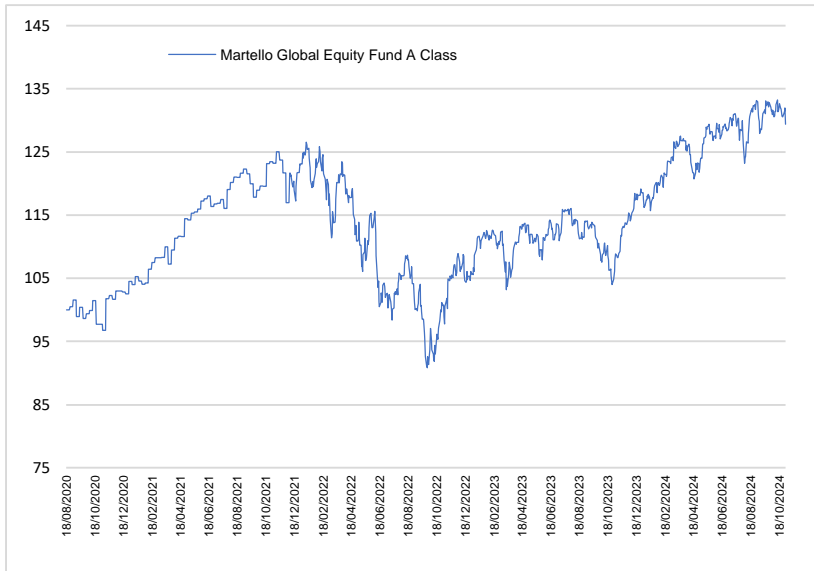

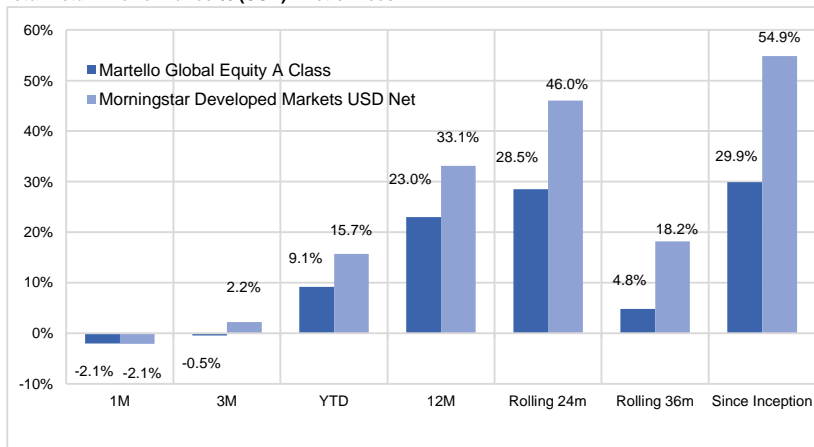
Fund Performance

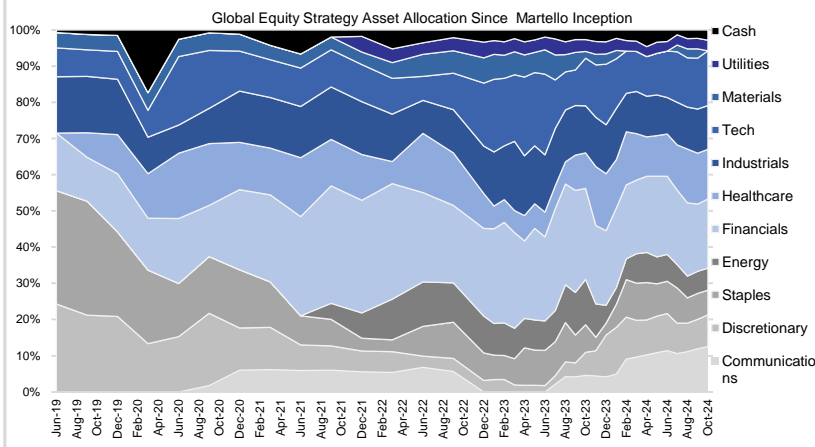

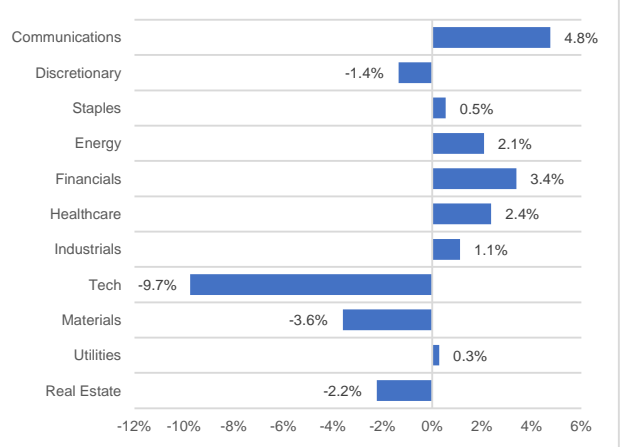

Global Equity Fund Sector Relative Positioning

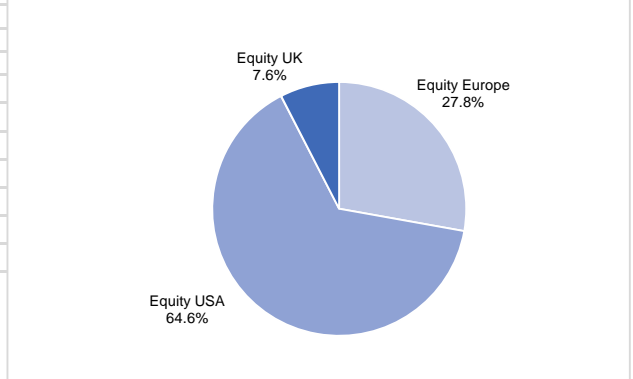

Fund Commentary – October 2024

There was a lot of noise to contend with during October. Economic releases, US elections and the start of earnings season all impacting equity and fixed income markets during the month. Overall, it was a good month for fund performance and many of the fund holdings.

The after effects of the Fed's larger than usual 0.50% rate cut in September were beginning to impact October's performance with some market participants becoming cautious about longer term inflation. There was also the US elections to contend with which provided some additional uncertainty to the market as it was and still is such a closely contested race this term.

October was a volatile month for equities for a number of reasons. Earnings season for the third quarter got underway with a lot of news worthy results being reported. Some of the larger technology companies had good earnings growth but softer full year and 2025 guidance. Earnings season for the fund's holdings have been mostly positive this quarter. There have been a number of companies held that have reported revenue and earnings growth well above estimates with several upgrading full year guidance.

Over 80% of the fund's holdings have now reported with nearly all reporting better than expected earnings growth YoY. Garmin reported very strong numbers with revenue coming in 11% ahead of estimates and earnings coming in 39% ahead. The growth was driven by strong demand in their Fitness and Outdoor segments where revenue and operating profits increased substantially YoY.

Netflix reported during the month with strong subscriber growth coupled with increased revenue generated from each subscriber. The company is shifting its focus to capitalizing on its huge subscriber base whilst also reducing costs which is paying off. The stock bounced 11% following the results with a number of analysts increasing their price targets.

SAP, which has already been one of the best performing stocks in the fund YTD reported some better than expected numbers with top line growth flattered by the significant uptick in Cloud revenue growth which increased 27% YoY. The company cited AI as a key driver for the segments growth with around 30% of the Cloud contracts in Q3 including AI use scenarios.

Throughout October the best performing sectors were consumer discretionary (+6.0%) and financials (+3.3%) with the laggards being information technology (-6.3%) and consumer staples (-4.2%). The best performing individual stocks were Garmin (+12.7%), Netflix (+6.6%) and Visa (+5.4%). The worst performing were ASML (-18.8%) and Monolithic Power Systems (-17.9%). During October, the fund returned -2.1% with the benchmark returning -2.1%.

The Scheme is an open-ended investment company, which was registered with limited liability in Guernsey on 20 May 2010, and is authorised by the Guernsey Financial Services Commission ("GFSC") as a Class B Collective Investment Scheme. The Scheme is an umbrella company constituted as a Protected Cell Company under the Guernsey Companies Law. The provisions of the Companies Law enable a company to which it applies to create one or more cells for the purpose of segregating and protecting the assets within those cells so that, on the basis that the company complies with the conditions laid down by the Companies Law, liabilities of the company attributable to one cell can only be satisfied out of the assets of that cell and even if those assets are insufficient, recourse cannot be had to the assets of any other cell.

Guernsey International Management Company Limited is the registered Manager of the Scheme and the Fund, and is approved to provide investment management services to collective investment schemes in Guernsey by the GFSC. The Manager does not provide any guarantee, either with respect to the capital or the return of this cell. Martello Asset Management Limited (the "Investment Advisor") (Company Registration No: 127947) is responsible for managing the assets of the Fund. Martello Asset Management Ltd is licensed and regulated by the Jersey Financial Services Commission (Funds Services Business Licence 2324).

The Fund was approved by the Financial Sector Conduct Authority of South Africa on 30 July 2020 in terms of Section 65 of the Collective Investment Schemes Control Act, 2002 (the "Act"), Notice 2076 of 2003 as amended by notice 1502 of 2005 ("the conditions"). The Fund complies and is managed within the investment restrictions and guidelines for Foreign Collective Investment Schemes in terms of the Act. The Scheme and Fund are approved in terms of the Act. The Scheme is an affiliate member of the Association for Savings and Investment South Africa ("ASISA").

The Fund may use derivatives for efficient portfolio management purposes only, which may include currency hedging. Short-term borrowing will be allowed to the amount of 10% of the value of the Fund, only for purposes of the redemption of participating shares. Scrip lending will be allowed but may not exceed 50% of the market value of the portfolio. A schedule of fees and charges and maximum commissions is available from the Investment Advisor. The cell is valued daily at 23h00, on the business day preceding dealing day and is traded at the ruling price.
