

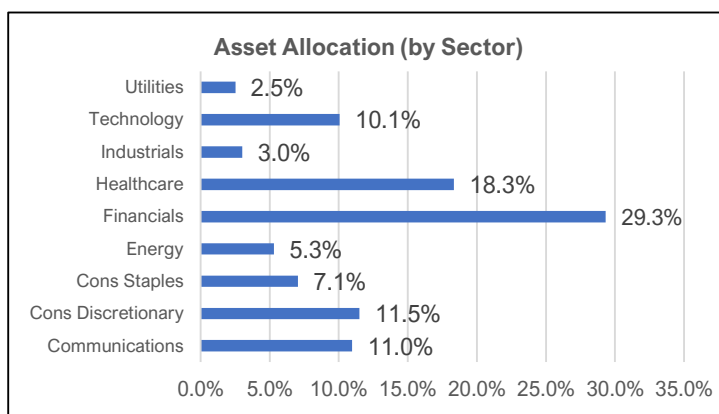
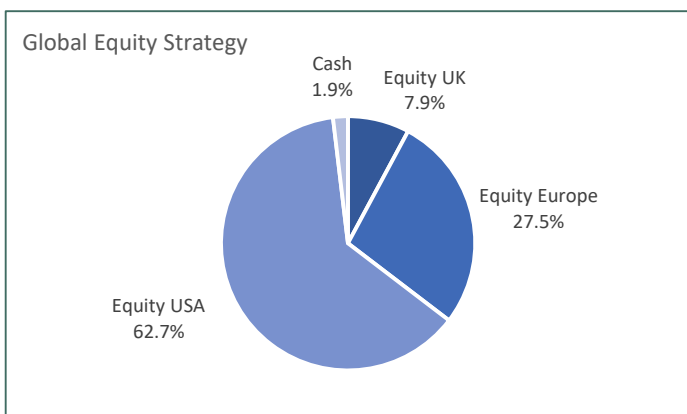
## Strategy Description

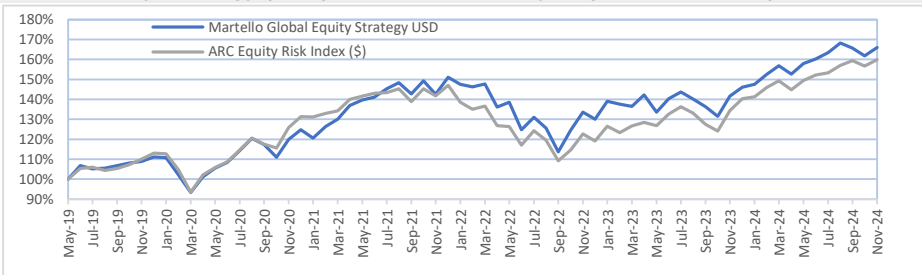
