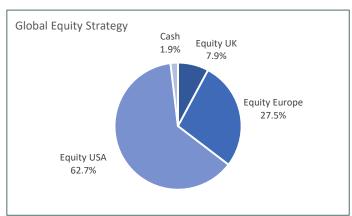

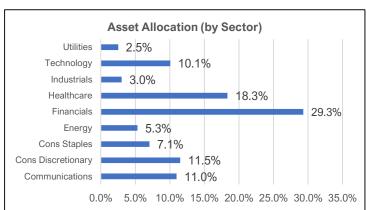

Asset Allocation Analysis





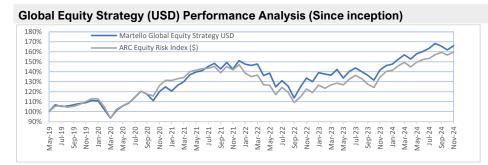
