The Martello Global Equity Fund ("the Fund") aims to achieve long term capital appreciation through investment in listed equities on a global basis.

The fund is primarily intended for investors with a long-term horizon of at least 5 years.


Investment Strategy

The Fund will invest in a diversified portfolio of listed equities. Assets of the Fund are typically limited to, but not confined to, those companies listed on the markets of the UK, Europe and North America.


The investment advisor will apply a rigorous investment selection methodology to select securities for the Fund's investment portfolio. These criteria are designed to ensure that the Fund invests in high quality businesses with proven management competencies and strategy execution.

It is envisaged that the investment portfolio of the Fund will be concentrated, comprising between 20 and 30 stocks. However, the portfolio will be invested with the aim of providing a

Monthly Returns Net of Fees (USD)





Fund Commentary - December 2024

Going into December, markets were still on an upward trajectory, a continuation of the Trump rally that led markets since early November. Towards the end of the month, some stronger than expected economic data and comments from the Fed that were more hawkish than expected caused the market to rethink their interest rate expectations for the following year which led to a subdued end to a strong year for equity markets.

There was broad weakness across the board for global equities with the US, UK and European indices finishing the month in negative territory in their respective currencies. Market breadth narrowed during the final two weeks of the month as the Magnificent 7 stocks ended the year even higher.

The Fed reduced rates by 25bps during the month which was largely expected by the market. What wasn't as expected was the more hawkish rhetoric and updated dot plot which showed a more shallow rate cut path for 2025. The 4 cuts that were expected in 2025, were reduced, with the median dot now implying 2 cuts.

Performance for the month was ahead of benchmark for the much of the month. There were a few stock specific events detracted from the funds monthly figures. Novo Nordisk had a tough month following the release of trial data for its new weight loss drug. The results were slightly less than the market was expecting leading to a sell off towards the end of the month. UnitedHealth also struggled during December due to the CEO Brian Thompson being fatally shot ahead of the companies earnings release. Although there were some outsized stock specific returns, the fund was inline if not slightly ahead of the benchmark for the majority of the month.

The best performing sectors throughout December were communication services (+6.0%), consumer discretionary (+2.6%) and technology (+1.2%) with the detractors being healthcare (-12.6%) and energy (-10.5%). Looking at the individual stocks, the best performing were Alphabet (+12.2%), HSBC (+5.6%) and Amazon (+5.6%) with the laggards being Novo Nordisk (-19.2%) and UnitedHealth (-16.8%). The fund returned -2.7% versus the benchmark return of -2.9%.

The Martello Global Equity Fund (the "Fund") is a cell of The Offshore Mutual Fund PCC Ltd (the "Scheme") (Registration Number 51900). The Scheme is an open-ended investment company, which was registered with limited liability in Guernsey on 20 May 2010, and is authorised by the Guernsey Financial Services Commission ("GFSC") as a Class B Collective Investment Scheme. The Scheme is an umbrella company constituted as a Protected Cell Company under the Guernsey Companies Law. The provisions of the Companies Law enable a company to which it applies to create one or more cells for the purpose of segregating and protecting the assets within those cells so that, on the basis that the company complies with the conditions laid down by the Companies Law, liabilities of the company attributable to one cell can only be satisfied out of the assets of that cell and even if those assets are insufficient, recourse cannot be had to the assets of any other cell.

The Fund complies and is managed within the investment restrictions and guidelines for Foreign Collective Investment Schemes in terms of the Act. The Scheme and Fund are approved in terms of the Act. Short-term borrowing will be allowed to the amount of 10% of the value of the Fund, only for purposes of the redemption of participating shares.
