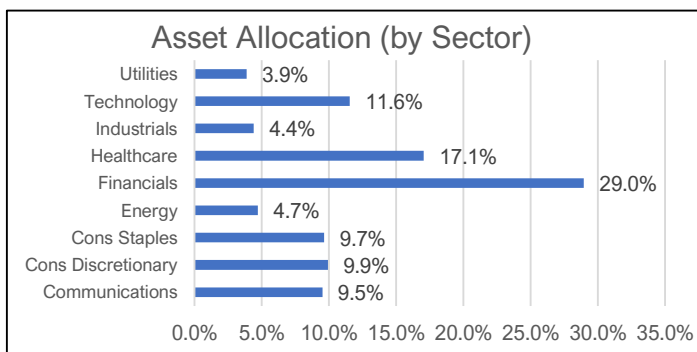
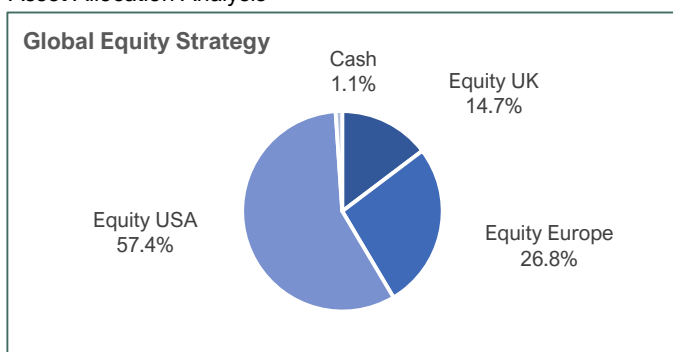


Strategy Description

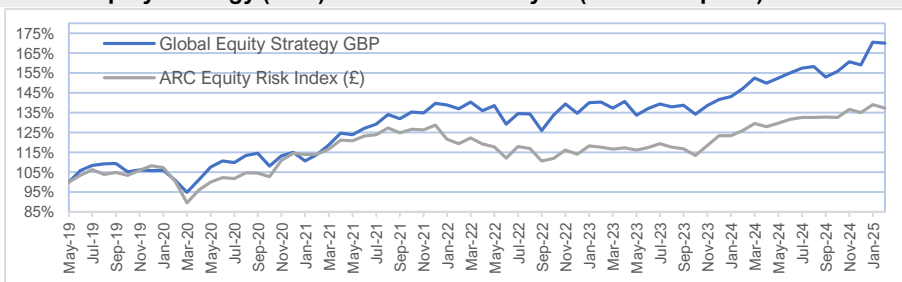
