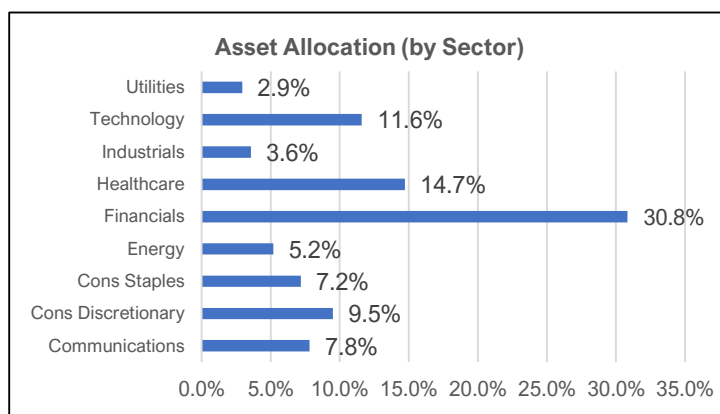
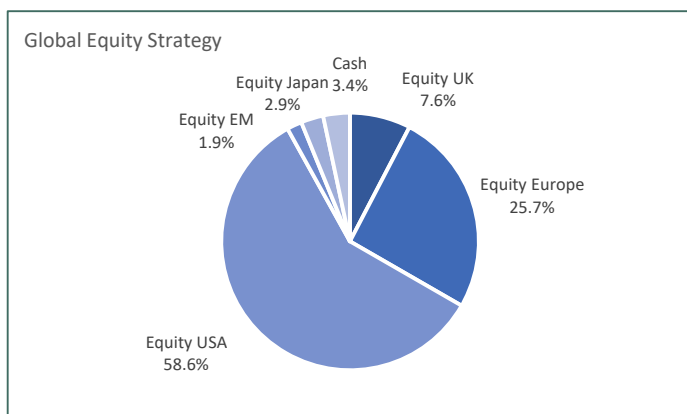


Strategy Description

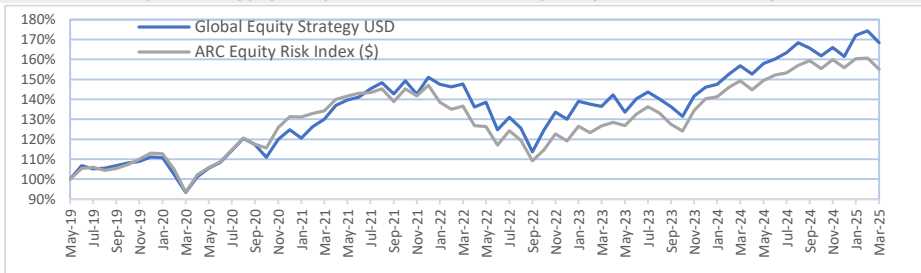
